South Dublin County Council, as planning authority, hereby gives notice pursuant to Section 13(2) of the Planning and Development Act 2000 (as amended), of Proposed Variation No. 1: Draft Clondalkin Local Planning Framework to the South Dublin County Development Plan 2022-2028.

Reason for Variation:

The Draft Clondalkin Local Planning Framework has been prepared to deliver on QDP14 Objective 3 of the South Dubin County Development Plan 2022-2028 (CDP) and consists of a written statement and associated objectives and maps. In delivering on the CDP objective, the draft plan is supported by a Local Transport Plan, Conservation Plan and Architectural Conservation Area Appraisals and by the following environmental reports:

- An Environmental Report as part of a Strategic Environmental Assessment pursuant to the European Strategic Environmental Assessment Directive (2001/42/EC) and the Planning and Development (Strategic Environmental Assessment) Regulations 2004 (as amended).
- An Appropriate Assessment (AA) screening determination pursuant to the EU Habitats Directive (92/43/EEC) and the Planning and Development Act 2000 (as amended).
