- (a) Packaging received means all packaging and packaging material (primary, secondary or tertiary) received onto the premises named in Section 3 (including imported packaging material, packaging associated with imported goods and pack-filled packaging)
- (b) Gross Packaging Supplied means packaging received <u>less back-door waste and/or packaging not supplied (kept in warehouse)</u>. The levy applied by the LA will be on the manufacturing brand packaging supplied when packaging exported, packaging other label & packaging destined for reuse do not apply
- (c) Packaging exported means packaging material and packaging where such material or packaging is supplied by, or used in the supply of products by, that producer to persons outside of the State
- (d) Other Label means packaging on product that will have the name of the store where the product will be sold rather than the name used by the major producer
